## KIRAN HOSPITAL VISIT REPORT

A visit to KIRAN HOSPITAL, SURAT was arranged for the students of Pharm - D IV year (Maliba Pharmacy College) on 27th February 2021. A batch of 20 students along with a faculty member Dr. Avinash Khadela had visited the hospital.

The visit started at 12:00 pm in the hospital. Students gathered in the conference room where they started it with the video presentation including the introduction of Kiran Hospital. It is a hospital located in Katargam, Surat, India and managed by Samast Patidar Aarogya Trust ("Not for profit" organization), which is headed by the Govind Dholakia. The hospital was inaugurated by the Indian Prime Minister Shri Narendra Modi on 17 April 2017. It consists of 550 beds and is 13 floored hospital and has 6 pharmacy departments which are present on different floors. The hospital is NABH accredited.

It has various departments like Pulmonary, ENT, Urology, ICU, Gastroenterology, Dental, Dermatology, Nephrology, Plastic-Surgery, Neurology, Cardiology, Radiation oncology and also many surgery departments. The ICU is consisted of 113 beds. It also has facility of air ambulance. First floor has OPD and emergency department, Second floor and Third floor has ICU, Fourth floor has Operation Theatre, Fifth floor has Conference room and Pharmacy, Sixth floor has General ward for patients with Maa-Yojna, Seventh floor has General ward for patients with Medicare.

Followed by brief introduction of hospital, the second presentation was given by Ms. Ekta Patel where she explained us about the clinical pharmacists duties and activities performed in the hospital which includes IP and OP Prescription audit, ADR reporting, Medication error and Management of Medicines. The detailed information on all the topics was explained with the statistical report of the hospital of previous year.

After the presentation students had visited to Clinical Research Departments on Third floor. The Head of the department along with his team explained us about various rooms in the department like Sample collection room, Investigational Product storage room, Documentation and Meeting room. They explained students about how they conduct the trials and also overview of clinical trials.

Afterwards students have reviewed case sheet of the patient where they were explained about the different documenting sheets and the case papers of the patient. Nursing notes and their practice of documenting was explained. Also the head nurse explained students about bio cabinet for the preparation of chemo medications.

Lastly students visited ICU where they reviewed the patient case sheet and the various instruments used. Also the detailed working and monitoring of the instrument was explained. The visit ended with vote of thanks to Ms. Ekta Patel which was given by Dr. Avinash Khadela.

Overall, the visit was very informative and enjoyable. Students came to know regarding the role of Hospital and Clinical Pharmacist in the overall health management.
