Responsibilities :-

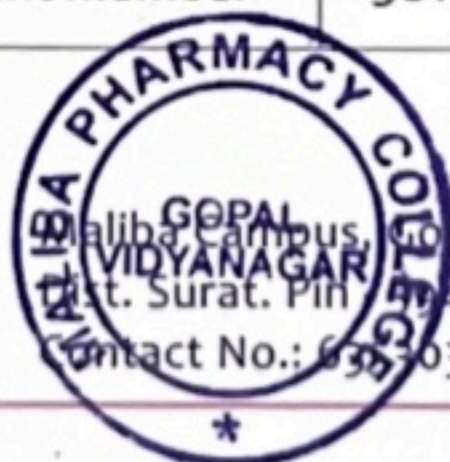
- 1) To ensure compliance with the provisions of UGC regulations 2009 at the institute level.

Senior Level :- To guide and support as well as to interact with freshers through junior-level mentors.

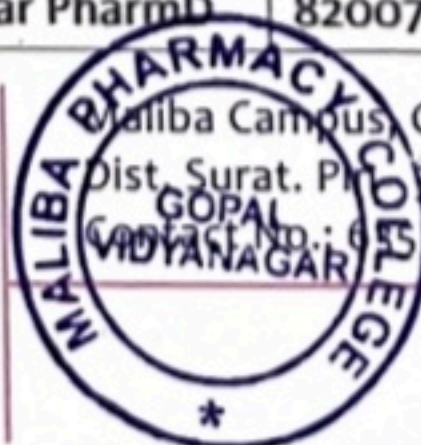
