Eligibility and requisite qualification for admission in Pharm. D

1. Student should have passed in any one of the following examinations:
 - a. 10 + 2 examinations with Physics and Chemistry as compulsory subjects along with one of the following subjects: Mathematics or Biology from schools located in Gujarat and affiliated to Gujarat Board or CBSE or ICSE or International School Board **in PCB/PCM theory**
 - b. Should have appeared in GUJCET/NEET/JEE examination conducted in the year 2019

OR

2. **Students from other states of India** should have passed in any one of the following examinations: 10 + 2 examinations with Physics and Chemistry as compulsory subjects along with one of the following subjects: Mathematics or Biology from schools affiliated to state Board or CBSE or ICSE or International School Board **with minimum 60% marks in PCB/PCM theory**

OR

3. A pass in D. Pharm. Course from an institute located in Gujarat and approved by Pharmacy Council of India under section 12 of the Pharmacy Act

OR

4. Any other qualification approved by Pharmacy Council of India as equivalent to any one of the above examination.

The application process involves the following stages and steps:

- The candidate has to fill and submit the application form online (**available from website <https://app.utu.ac.in/admlng/AdmissionInquiries>**) for admission on or before **16/06/2019**.
- Selection will be made on the merit based on marks secured in PCB/PCM conducted by various Boards of Authority.

- 2) Last dates for Application Submission: **16/06/2019**
- 3) Display of merit list: **18/06/2019**
- 4) Counselling for Admission: **20/06/2019, 10 A.M. (Venue: MPC hall)**
- 5) Commencement of classes will be informed at the time of Selection/Admission

Additional instructions

- The candidate and the parent / guardian should sign on the space provided in the application form.
- Please note that application fee is NON- REFUNDABLE, even if the application is rejected because of deficiency in application or due to in-eligibility of the candidate or if the applicant does not appear for the counseling when called for.

- Any application received after the last date will be rejected.

Counseling

The counseling sessions will be conducted at Maliba Pharmacy College. Date will be informed on web site and intimated to candidate. On the day and date candidate must remain present and appear in counselling.

At the time of counseling the candidate is REQUIRED TO PRODUCE THE DOCUMENTS IN ORIGINAL (original and additionally keep one set of photo copy). If the candidate secures admission documents will be retained for further process. If the candidate fails to produce all or any of the document(s) listed herein above candidate will immediately forfeit/lose claim for a seat and admission will be granted to next candidate in the merit.

Merit & Admission

Maliba Pharmacy College will prepare a merit list amongst the candidates who have applied for admission to the Pharm. D course with the marks (10+2/PUC/HSC/D.Pharm.,etc.,) in relevant subjects conducted by various Boards / University of Authority. The merit list will be displayed as per the scheduled date on college notice board & in the website: <http://utu.ac.in/>.

The selected candidates will be allotted admission based on merit. In case of two more candidates having equal merit. The inter-se merit of such candidates will be determined & decided on higher marks in the order of preference as under:

- 1) GUJCET/NEET Marks.
- 2) Total of Marks obtained in subject other than Physics, Chemistry, Mathematics/Biology marks

If a student listed in first merit list fail to secure admission on or before the mentioned date, he/ she loses the right for admission. The second merit list of students will be based on number of vacant seats remaining after first round. Similar process will be carried till complete admissions of 30 students are made.
